DEAR FRIENDS.

It was a privilege to serve as YCF's Board Chair in 2020, a year none of us will soon forget.

The year was defined by the COVID-19 pandemic, which impacted us all and placed particular strain on the nonprofit community. While the majority of YCF's assets are invested with the goal of providing a long-term and growing funding stream for future grantmaking, YCF is also uniquely positioned to respond to immediate community needs such as the recent pandemic. YCF responded by establishing an Emergency Impact Fund to assist nonprofits in addressing basic human needs, such as food, shelter, and safety. Through the generosity of our community, over \$150,000 in emergency grants were made to 45 local nonprofits during 2020.

In 2020, YCF awarded over \$850,000 in total grants and scholarships. Seven new endowment funds were established, and as of year-end, YCF managed over 150 funds with \$18 million in total assets.

As we reflect on the accomplishments of the past year, we also look forward to celebrating YCF's 10th anniversary in 2021. This marks 10 years since the merger of the Community Foundation of North Central West Virginia and the Greater Morgantown Community Trust.

Whether you've been with us since the beginning or have just recently partnered with YCF, we are grateful for your support. Together, we will continue to make a positive impact on North Central West Virginia.

TYPES OF FUNDS

YCF offers a variety of funds to meet both donor and community needs. Donors select the fund name and determine the fund's purpose. The fund is invested by YCF, and the annual earnings may be awarded based on the donor's wishes. For a full list of current funds, please visit ycfwv.org.

AGENCY ENDOWMENT FUNDS provide long-term investments for local nonprofit organizations. Annual earnings support a nonprofit's greatest needs while YCF assumes reporting and investing responsibilities.

DONOR ADVISED FUNDS allow donors to actively participate in the grant-making process as a flexible way to address charitable interests as they change over time. Donors can involve their children as advisors to perpetuate a family tradition of philanthropy.

DONOR DESIGNATED FUNDS enable donors, at the time the fund is established, to name one or more organizations to permanently benefit from the fund. YCF ensures the designated recipient(s) receive support as long as they remain in existence and continue to fulfill the intended charitable purpose.

FIELD OF INTEREST FUNDS allow donors to support an area or issue of importance to the community. Fields of interest may include but are not limited to: arts, environment, education, youth services, animals, or health care. The endowment may grow through gifts from others who see them as a way to address their own charitable interests. Under the direction of the YCF Board of Directors, grant-making addresses the specific area identified by the fund.

SCHOLARSHIP FUNDS are established to assist students with education. Donors may determine eligibility requirements and can designate funds for any level of education. Distributions are made in accordance with YCF policies, providing funds to the specific institution in which the student is enrolled.

IMPACT FUNDS are donated without stipulations or conditions; they allow YCF maximum flexibility to respond creatively and effectively to our communities' most compelling needs and opportunities. These funds are among the Foundation's most important assets to address long-term community planning. Grant-making from a fund is at the discretion of the YCF Board of Directors within the bounds of the general charitable purposes of the Foundation.

On December 31, 2020, YCF managed assets totaling \$18,399,134.



Individuals, businesses, and nonprofit agencies may establish endowment funds with YCF for a minimum of \$10,000. Scholarship funds require \$20,000. The minimum must be achieved within three years. The funds are invested and either restricted for a specific charitable purpose or unrestricted for the greatest needs of the community.

Christian Help Endowment Fund

Christian Help's Board of Directors set a goal to build a \$5 million endowment by the organization's 50th anniversary, in 2025. The investment income from the endowment will be used annually for operational expenses such as facility upkeep, salaries, and services. Achieving this goal will then allow 100% of donations to support clients in direct aid.



Clarksburg-Harrison Public Library Foundation Endowment Fund

This endowment fund's annual earnings will be used to provide financial support for the Clarksburg-Harrison Public Library (CHPL) to offer its services and programs. The CHPL Foundation supports current library needs and encourages philanthropy to sustain the library into the future.

Deena Baker WV Education Fund

Established by Deena Baker-Nel

This donor advised endowment supports educational needs in North Central West Virginia. Born and raised in Fairview, WV, Deena earned a bachelor's degree in psychology from Ohio University and a master's degree in counseling from West Virginia University. She resides in Los Angeles, CA, with her husband and two children.



EQT Scholarship Fund

This scholarship provides support for graduating high school seniors or an equivalent homeschooled resident of Marion County, WV, pursuing either an associate's or bachelor's degree in a field that is utilized by the oil and gas industry (e.g., Computer Science or

Information Technology; Civil, Chemical, or Petroleum Engineering; Energy or Land Management; Environmental Science; Geology; Safety Science; or Welding). The EQT Foundation provides five \$1,000 one-time awards, as well as one \$18,000 per year award that is renewable for up to four years.

George E. and Joanne R. Davis Memorial Scholarship

Established by the family of George E. and Joanne R. Davis This endowed scholarship is in memory of the former, Fairmont-based Davis Furniture owners. The annual \$1,000 scholarship will be awarded to a West Virginia resident pursuing an undergraduate degree as a full-time student at West Virginia University, where George played basketball. Marion and Monongalia County residents receive preference. Applicants must be graduating seniors who participated in organized athletics while in high school or during their teenage years.



Harrison County Senior Citizens Center Endowment Fund

The Harrison County Senior Citizens Center Endowment supports the charitable, scientific, or educational purposes of the Harrison County Senior Citizens Center, Inc. located in Clarksburg, WV.

Taylor County Children and Families Endowment Fund

Annual earnings generated by the fund will provide long-term sustainability for the organizational needs of the Taylor County Family Resources (TCFR). Current programs include hunger relief, child abuse prevention, substance abuse prevention and recovery efforts. TCFR's goal is for the fund to reach \$10,000 by December 31, 2021.









FUND HIGHLIGHTS



Marion County

Disability Action Center of Marion County Education and Resource Fund This fund supports The Disability Action Center, Inc. (DAC) in providing grants for education, scholarships, and resources for individuals with disabilities. The DAC focuses its support on the educational needs of individuals with disabilities and their families. Additionally, the DAC provides resources to include home modifications, assistive technology, personal development, training, and support services when funds are available. The fund distributes an annual scholarship called The Assist Award to special needs graduates of the three Marion County High Schools. The students are honored during their Senior Recognition ceremonies alongside their peers.

Harrison County

J. Cecil Jarvis Memorial Scholarship Fund This annual \$5,000 scholarship provides support to a post-graduate student from Harrison County for further education in journalism, medicine, or law. It was established in memory of J. Cecil Jarvis, who passed away in May 2007. Mr. Jarvis was a former publisher of the Exponent-Telegram newspaper in Clarksburg and a prominent Harrison County attorney. Since 2011, the fund has awarded scholarships to nine students totaling \$28,800.

The Arts Fund

The Arts Fund supports the Organizational Arts Grant program, which seeks to broaden the base of support for the arts in the greater Morgantown area. This grant program is made possible through a collaborative effort between YCF and the Arts Council of Greater Morgantown, with funding from the City of Morgantown, the Monongalia County Commission, and the Douglas H. Tanner Memorial Fund for the Arts.

Preston County

Jim Dunn Memorial Scholarship Fund This fund provides scholarships to outstanding West Virginia athletes who plan to pursue cross country or track and field in college. It was established in memory of Jim Dunn, who passed away in May 2007 and was a well-known and admired member of the Morgantown community. Jim was a manager for several local restaurants, a Special Olympics coach, a volunteer with many youth sports programs, and a caring husband, father, brother, and dear friend to many. To date, the Jim Dunn Memorial Scholarship Fund has awarded \$26,700 to 33 students.

Taylor County

Taylor County Charitable Interest Fund The Taylor County Charitable Interest Fund (TCCIF) was established in 2008 to support the cultural, social, education, and economic needs within the county and improve the quality of life for Taylor County residents. To date, the TCCIF has awarded \$7,445 to nonprofit organizations in Taylor County. In 2020, TCCIF awarded two \$500 grants to the Salvation Army of Grafton and Taylor County Family Resources.

The Change Initiative received an Emergency Impact Fund grant to support their church-based homeless shelter in Clarksburg.





The Disability Action Center in Fairmont received an Emergency Impact Fund grant to support their "Safe at Home" connection kits.

In response to the ongoing COVID-19 pandemic, the YCF Board of Directors established the Emergency Impact Fund. The new fund provides grants to nonprofit organizations addressing the most critical needs in YCF's five-county region (Harrison, Marion, Monongalia, Preston, and Taylor Counties).

Grants were used for unanticipated, additional expenses related to COVID-19. The following emergency needs were considered for funding: food, shelter, and other basic needs for the most vulnerable members of our community.




